

WOMEN'S COMMUNITY SHELTERS: SILENT AUCTION, APRIL 10 – APRIL 16, 2025

TERMS AND CONDITIONS

1. Introduction

1.1. These terms and conditions apply to all participants (bidders) in the silent auction (the "Auction") organized by Women's Community Shelters (the "Organisation"). By placing a bid, all bidders agree to abide by these terms and conditions.

1.2. The Auction is conducted to raise funds for Women's Community Shelters (ABN: 54 153 006 556).

2. Auction Details

2.1. The Auction will take place from Thursday 10 April 2025, 12.00am (AEST) – Wednesday 16 April 2025, 23.59pm (AEST) online via Supporterhub (ABN: 26 616 473 084).

2.2. There is only one item. The auction item has been donated, and all proceeds from the auction will benefit Women's Community Shelters.

2.3 The auction item is a painting, with the details as follows:

3. Eligibility to Participate

3.1. The Auction is open to all individuals aged 18 years or older.

3.2. The Organisation reserves the right to exclude any person from participating in the Auction at its discretion.

4. Bidding Process

4.1. To place a bid, participants must complete a bidding form online via Supporterhub, during the Auction period.

4.2. Bids must be made in whole Australian (AUD) dollar amounts as indicated in the Auction.

4.3. The Auction will close on Wednesday 16 April 2025, 23.59pm. Any bids placed after the closing time will not be accepted.

4.4. Bidders may place multiple bids on any item during the auction period.

5. Winning Bids and Payment

5.1. The highest bid at the time the Auction closes will be considered the winning bid.

5.2. Winners will be notified on Thursday 17 April 2025 via phone and a confirmation sent via email. The winning bidder will be required to confirm their acceptance of the item.

5.3. The winning bidder agrees to pay the total amount of their bid to the Women's Community Shelters, including any applicable taxes, fees, and delivery costs.

5.4. Payment must be made by accepted payment methods including credit card, bank transfer, or cheque, no later than seven (7) days following the close of the Auction.

6. Transfer of Ownership

6.1. Upon payment being received in full, the ownership of the item will transfer to the winning bidder.

6.2. All item is sold "as is." The Organisation makes no representations or warranties regarding the condition, authenticity, or quality of the items unless otherwise stated.

6.3. The item may require additional arrangements for delivery or collection. Details of delivery or collection will be provided to the winning bidder.

7. Auction Items

7.1. The Auction item is described as accurately as possible, but no guarantees or warranties are made regarding their quality, condition, or authenticity unless expressly stated in the Auction catalogue.

7.2. The item has been donated, and no refunds, exchanges, or returns will be allowed or a credit note provided.

8. Liability

8.1. The Organisation shall not be liable for any loss, damage, or injury to the bidder or their property arising from the use or acceptance of the auction item.

8.2. The Organisation is not responsible for any issues that arise post-auction, including delivery delays, defects, or damages to the auctioned item.

9. General Conditions

9.1. The Organisation reserves the right to cancel or amend the Auction, or the terms and conditions, at any time without prior notice.

9.2. The Organisation is not liable for any errors or omissions in the Auction process, including but not limited to technical issues with the online platform or errors in bid records.

9.3. In the event of a dispute, the decision of the Organisation will be final.

9.4. The Organisation may contact bidders with future communications related to the Auction or their participation. Participants can opt out of receiving such communications.

10. Governing Law

10.1. These terms and conditions shall be governed by the laws of New South Wales, Australia.

11. Privacy

11.1. The privacy and security of entrant personal information is important to the Organisation. The Organisation is committed to treating personal information in accordance with Women's Community Shelters Privacy Policy, a copy of which can be found by visiting www.womenscommunityshelters.org.au.
